FINANCIAL STATEMENT: Our Annual fund raising drive for the fiscal year ending September 30, 2011 was the lowest gross contribution since the year 1998 (See enclosed Council Reporting Gross Contributions). I am sure there are many reasons. The primary one being the economy. It is essential that we start planning now for the annual drive in October of 2012. I cannot over stress the importance of the funds that you raise for your local community program. These funds are needed more now that ever before. Without your support, many of these activities within your local communities will have to close their doors. I know that as Knights of Columbus you will never let this happen. So, please we need all five hundred and forty five (545) councils to participate in this year's drive (Oct 2012) in support of People with Intellectual Disabilities.

GROSS CONTRIBUTIONS: Through the great effort of all our Councils over the past twenty-four (24) years, new heights in gross Columbianism for charity have been achieved. Our Councils, through the efforts of the membership, have collected over **Fifteen Million Dollars** (\$15,084,722.40). On behalf of the Board of Directors, We cannot thank you enough.

<u>DONATIONS</u>: The success of the 2011 drive really belongs to the many councils who solicit donations from the local businesses and corporations in their area.

<u>PRO-RATA SHARE</u>: THE PRO-RATA SHARE (WHICH IS THE I. D. OPERATION FUND) WILL BE 7½% FOR THE 2012 DRIVE.

<u>COUNCILS</u>: For the year 2011, our records indicate 418 Councils participated. However, only 386 Councils have sent in their M/R 200 report with gross contributions of \$692,014.55. The Foundation has received (less council expenses) \$ 665,825.97. The Foundation can not over emphasize the importance of receiving the M/R 200 form along with the net proceeds from the drive. **IT IS ESSENTIAL THAT THESE FUNDS BE FORWARDED TO THE FOUNDATION TREASURER WITHIN A THIRTY (30) DAYS AFTER THE CONCLUSION OF THE DRIVE, AS REQUESTED ON THE FORM.**

Should a Council not have a qualified recipient, the monies <u>MUST</u> be sent in anyway, using the M/R 200 form. The Request for Distribution will be held while deciding whom the recipient is, until September 30th of the year following the drive. At that time, it will be automatically deposited in the program that the Foundation Board of Directors designates.

AS WE HAVE MENTIONED MANY TIMES IN THE PAST, YOU ARE DEALING WITH PUBLIC FUNDS AND YOU ARE ACCOUNTABLE FOR ALL FUNDS COLLECTED.

Those Councils who have a gross revenue of \$4,000.00 or more by April 1, 2012 will receive a plaque at the State Convention.


